## Bannockburn Wins Battle of the Neighborhoods for Glen Echo Park

The Bannockburn Community raised \$9120 for Glen Echo Park's Year End Appeal Battle of the Neighborhoods 2025. As your community representative serving on the Glen Echo Park Partnership for Arts and Culture Board (GEPPAC), I want to thank all of those who generously gave donations to the Park helping Bannockburn win first place for the third time. The Town of Glen Echo came in second raising \$7786. A total of \$162,500 was raised. Roughly \$22,500 will go to fund repairs for the neon sign at the front entrance.

Fifteen communities competed to raise the most funds from Giving Tuesday through December 31<sup>st</sup>. We thank Erin McCahill of West Halbert Road and Barbara Martin of Dunrobin Drive for helping with raising funds from the Bannockburn community. Martin, a fellow GEPPAC Board member, organized the competition, hosted a Mahjong pajama party, and got *Bethesda Magazine* to promote the battle of the neighborhoods with a [feature article](#).

## BCA Board Meeting, January 6<sup>th</sup>

The first meeting of 2026 for the Bannockburn Civic Association (BCA) took place on January 6<sup>th</sup>. In attendance were Beth Rogers, Mike Zangwill, Patty Howie, Laura Chavez, David Hecht, Steven Solomon, Katy Levine, Randall Ingate, and Nancy Forden.

The meeting started with an update of Bannockburn events. BCA Board President Mike Zangwill reported on a documentary that is being made about the annual Spring Show, now going into its 70th year. Beth Rogers organized a Town Hall at the Clubhouse on March 1<sup>st</sup> [see flyer on page 6] to showcase candidates running for County Council District One to replace Andrew Friedson who is running for County Executive as well as candidates running for Circuit Court Judge.

David Hecht, one of the leads of the BCA's Woodlands Stewardship Group (WSG), reported on three woodlands stewards workdays held at Merrimack Pool, Bannockburn Elementary School (BES), and Bannockburn Pool. Currently the WSG is holding workdays twice a month. Hecht and fellow WSG lead Katy Levine will meet with BES and provide community input for a tree planting effort between MCPS and [Tree Montgomery](#); he estimates 12 to 20 trees may be planted on the school grounds. A brief discussion was held about organizing a neighborhood walk to highlight the WSG's environmental efforts which would be initiated by the BCA Environmental Committee.

At 8 PM Zangwill introduced Mona Kishore, President of the Glen Echo Park Partnership for Arts and Culture (GEPPAC) Board. A Town of Glen Echo resident for the past ten years and with two children at Bannockburn Elementary School (BES), Kishore has served on numerous boards and in non-profits. In addition to her work at GEPPAC, she chairs Governor Wes Moore's Commission on Middle-Eastern American Affairs. Kishore's husband, Ayan, is Chair of the Washington Folk Festival. (The [2026 Folk Festival](#) will be held on August 23<sup>rd</sup>.)

Kishore shared that she gets many questions about how changes happening at the federal level affect the Park. She claimed that all of the programming that was available before the current Trump administration remains even though DEI language has been removed. Signage about the civil rights movement remains throughout the Park. Beth Rogers asked that if it were to be removed, she wants

the plaque commemorating Bannockburn's role in supporting those who helped desegregate the Park (across from the carousel) to be given to the Bannockburn Clubhouse.

GEPPAC, in an agreement with the National Park Service, oversees the arts programs and the physical facilities, many of which are historical buildings such as the Spanish Ballroom, the stone tower, and the carousel. Repair and maintenance costs are quite high. Currently the iconic Glen Echo neon sign needs repair. These ongoing expenses highlight why so much of the funds raised for GEPPAC are earmarked for repairs. GEPPAC relies on donations from individuals, corporations, and foundations. It is possible to direct donations towards specific projects or buildings in GEPPAC.

Kishore noted that there is a general effort to make the Park's indoor and outdoor spaces more appealing. There are plans in the works to designate part of the Park as an arboretum and design a tree walk and sculpture garden using some of the work of the late [Raya Bodnarchuk](#), an artist who lived in the town of Glen Echo.

Kishore would like to increase earned income from rentals and this year there are already many commitments. While the Park doesn't advertise its venues heavily, Kishore praised the existing online catalog, [glenechopark.org](http://glenechopark.org), which provides detail on all of the programs and rental spaces. Kishore

spoke to the need for a master plan for expanding programs and using space more effectively. The Spanish Ballroom needs an HVAC system and other repairs to expand its use. Renovations to the Ballroom alone are anticipated to cost approximately \$8 million.

Kishore mentioned that the Park will host two screenings on February 7<sup>th</sup> of "Ain't No Back to a Merry-Go-Round," the documentary about the civil rights protests at the Park in the early 1960s in which the Bannockburn neighborhood is prominently featured.

Katy Levine observed that it would be helpful if the Park expanded its programming so that the Park became a three-to-four-hour destination for young families. Levine also said that there was a dearth of timely information about summer programming for families attempting to schedule/structure activities, leading many area families to treat Park summer programs as fillers.

Kishore responded that GEPPAC is not able to expand activities as they are understaffed and currently stressed as a result. The cooperators (or-

ganizations such as the Aquarium and Washington Conservatory) are still recovering from the financial impact of the pandemic. On the plus side, there are efforts to centralize cooperators into one box office so that visitors don't need to go to separate places for tickets to events. Kishore reminded everyone that many Student Service Learning hours opportunities are available at the Park.

Lastly, Kishore praised the members of the GEPPAC Board, including Mike Zangwill who has been a GEPPAC Board member for many years; the ongoing support of the Bannockburn Civic Association, which buys a table each year at the Gala, the Park's largest fundraiser; and the Bannockburn neighborhood which again raised more money this year in the end-of-year fund drive than any of the other local neighborhoods, thanks in large part to the efforts of board member Barbara Martin of Dunrobin Drive. [see article page 1] Finally, added Kishore, GEPPAC Board meetings are open to the public.

The next BCA Board meeting is scheduled for March 10<sup>th</sup>.




